## TOWN OF AZTALAN, JEFFERSON COUNTY - ORDINANCE #.0293

THE TOWN BOARD OF THE TOWN OF AZTALAN, JEFFERSON COUNTY, WISCONSIN DO ORDAIN AS FOLLOWS:

## SECTION 1 BURNING REGULATIONS

- A. No person shall burn plastic, rubber, petroleum products, diapers or animal waste in the Town of Aztalan.
- B. No person shall burn rubbish, trash, leaves or debris within 75 feet of any building not owned by said person unless that person obtains written permission from the owner on record for each and every building within 75 feet of the burning site and said person retains that written permission in his or her possession at all times that burning is taking place.

C. In any and all other parts of the Town of Aztalan burning will be allowed subject to the following conditions:

- 1. No person shall kindle any outdoor fire over 6 feet in diameter within the Township without first securing a permit therefore from a Town Employee or a Town Board member.
- 2. No burning shall be allowed on windy days where wind gusts reach 20 miles per hour.
- 3. No burning shall be nearer that 30 feet to the closest portion of any portion of any building, lumber pile, wood pile, wooden fence or other material of a combustible nature.
- 4. No leaves or other debris shall be burned on any road, street or public right-of-way.
- 5. Burning is allowed only during daylight hours and must be totally extinguished at dusk. Fire must be attended at all times.
- D. Notwithstanding any other provisions of the ordinance of the Town of Aztalan, the Chief of the Fire Department or his designated agent may issue a permit to an organization to burn campfires. Such permits may only be issued upon application and must describe the plan for supervision of such activities and be signed by the person who will be responsible for such supervision.
- E. All fires, campfire or otherwise, burned at any other place or at any time must comply with all other regulations of the Ordinance of the Town and all State and County regulations.
- F. Fires started by the Fire Department for its training purposes or otherwise are exempt from the provisions of this ordinance.
- G. Any person or organization who violates the terms of this Ordinance shall be subject to the forfeit and pay to the Town of Aztalan in an amount not-to-exceed \$200.00 and not less than \$100.00 plus any costs of this action. In the event the fine imposed herewith by a Court shall remain unpaid then in that event the person found to have violated this Ordinance shall be subject to incarceration in the Jefferson County Jail having a term not-to-exceed 90 days.

## SECTION II SEVERABILITY

The severable sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a decision of a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision and not affect the validity of all other provisions, sections or portions thereof of the ordinance which shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provision of the ordinance are hereby repealed as to those terms that conflict.

## SECTION III EFFECTIVE DATE

This ordinance shall take effect immediately upon passage and posting of publication as provided by law.
