Whereas, year-to-date, the 57000.1 - Comprehensive Plan Expense Account has a surplus of \$1,600.00;

Whereas, year-to-date, the 50004 - Board & Shop Mileage Expense Account has a deficit of \$737.23;

Whereas, year-to-date, the 50015 – Legal Expense Account has a deficit of \$10,768.20;

Whereas, year-to-date, the 50026 - Unemployment Benefits Account has a deficit of \$3,330.00;

Whereas, year-to-date, the 55001 - Drug Testing Expense Account has a deficit of \$363.00;

Whereas, year-to-date, the 55002 - Equipment Maintenance Expense Account has a deficit of \$3,692.03;

Whereas, year-to-date, the 55004 - Fuel and Oil Expense Account has a deficit of \$1,815.22;

Whereas, year-to-date, the 55008 - Shop and Hall Supplies Expense Account has a deficit of \$1,100.44;

That the sum of \$738.00 is hereby transferred from the 55006 – Road Materials/Supplies Expense Account to the 50004 – Board & Shop Mileage Expense Account.

That the sum of \$1,110.00 is hereby transferred from the 55006 - Road Materials/Supplies Expense Account to the 55008 - Shop and Hall Supplies Expense Account.

That the sum of \$9,800.00 is hereby transferred from the 55010 – Wages Expense Account to the 50015 – Legal Expense Account.

That the sum of \$3,330.00 is hereby transferred from the 55010- Wages Expense Account to the 50026- Unemployment Benefits Expense Account.

That the sum of 1,000.00 is hereby transferred from the 57000.1 – Comprehensive Plan Expense Account to the 50015 – Legal Expense Account.

That the sum of \$370.00 is hereby transferred from the 57000.1 – Comprehensive Plan Expense Account to the 55001 – Drug Testing Expense Account.
